1. Directors' Report-Directors: John McCoy

The club as a whole continues to be in good financial standing operating at or below budget in most areas, and most areas are seeing a revenue increase from last year. The 2017 budget will be voted upon at the next meeting in December. By the time you are reading this, the high peaks info center (HPIC) will be under renovation and construction will be started on a new campground loop, wash house and concession stand at Heart Lake. Stay tuned for exciting news and celebrations for ADK's "second century" in 2017 as ADK turns 100!

2. Conservation Committee-Chair: Mary Coffin/Associate Chair: Kathy Disque

ADK-ON Conservation Committee Annual Summary

- 1. Boreas Pond Classification ADK and BeWildNY Proposal: In mid-October APA published 4 plans and none of them mirrored exactly the environmental groups plans. Watch for meetings and hearings throughout the state. None are in CNY but ADK is considering running busses to either Albany or Rochester. A large turnout of ADKers is expected. Watch for the Action Alert. ADK needs your support. Wednesday, December 7, 2 p.m. DEC headquarters, 625 Broadway, Albany. ADK and BeWildNY still support 2/3rds Wilderness except for 5.7 miles of Gulf Brook Rd. to LaBeir Flow open to motor vehicles and Wild Forest south of Gulf Brook Rd. Paddlers and hikers will still need to hike/portage to the ponds by foot for approx. 1 mile. A snowmobile trail is supported close to Blue Ridge Road in the Wild Forest to the south of Gulf Br. Rd. But no motorized access is suggested for the ponds themselves. If these purchases (Boreas Wilderness, Casey Brook Tract, MacIntyre east and west) are added as Wildernesses to the adjacent Dix Wilderness and High Peaks Wilderness then 280,000 acres of contiguous wilderness, largest in the east, will be created.
- 2. The New York State Constitution is up for possible revision in 2017 (every 20 yr.). The last revision was in 1997. The Conservation Committee will be considering the ramifications on the present Article 14 protections of the Catskill and Adirondack and all other Forest Preserves. If a Constitutional Convention is convened 100% of it is up for possible revision.

- **3.** ATV Use on Public Roads and Public (State) Lands: The NYS Assembly defeated the ATV budget bill passed by the Senate. BUT a similar bill will probably be included in 2017. Strong ADK support will be needed again to protect the Adirondack and Catskill Forest Preserve, State Forests throughout the state and other state lands through which our trails (FLT, NCNST etc.) pass. Only a repeat of the 1000's of responses will again defeat ATV bills. In 2016 ATV bills supported youth aged 12 and adults to ride ATVs on state lands and state roads at speeds up to 55mph.
- **4.** Over Crowded, Impacted High Peaks: Weekends and holidays this years have attracted 1000's to the high peaks, especially trailheads from Heart Lake and Route 73.

The impact on safety, sanitation and overuse has taken a toll on our mountain trails. DEC Rangers are stopping and turning around cars at South Meadow Rd. after the lot is full and ticketing any illegally parked cars between South Meadow Rd. and the Loj. DEC has prepared a list of hikes outside the High Peaks: http://www.dec.ny.gov/outdoor/9163.html.

- 5. <u>State Land Master Plan (SLMP) Amendments:</u> APA has voted to allow use of some non-natural materials in the Wild Forest areas such as steel cables for bridges as long as the decking is wood, fiberglass outdoor privy units etc.
- **6.** Rail Trail Compromise: DEC, APA and Governor approved a plan for NYS owned Adirondack RR tracks. Tracks will be removed from Tupper Lake to Lake Placid (34mi.) to build a multiuse trail. Stakeholders are meeting over the fall and winter to consider trail designs to accommodate snowmobiles, bikes and pedestrians. Part of the funding will come from scrap of the scrap metal from the rails. Tracks between Tupper Lake and Big Moose (45 mi.) as well as all the way to Utica will be restored for tourist trains.
- 7. <u>Conservation Committee trip</u> to The Great Swamp Conservancy brought out 22 participants on a beautiful fall day. We focused on restoration efforts to reclaim the wetland ecosystem after it was drained a century and a half ago for agriculture.
- **8.** Other issues discussed this year include: Essex Chain UMP implementation, NYS budget, EPF and legislation updates, invasive species monitoring both terrestrial and aquatic, potential ATV use of State lands, support for funding for the <u>Federal Land and Water Conservation Fund</u> [LWCF], SLUMP Land Bank Amendments.

7. LANDOWNER RELATIONS COMMITTEE -Chair: Bill Coffin

<u>Landowner Visits:</u> Committee members visited 38 landowners this year. 29 more are not available because they reside too far from our driving capability. Our visits are brief. Nearly all owners are very friendly and supportive.

<u>Emphasis</u>: The FLTC and the NCTA are not private use clubs like hunting. We are a non-profit, long distant community service for the hiking public.

<u>Landowner Committee:</u> Fewer workers were available this season due to some chronic illnesses and we wish good recovery. Those left still got the job done.

New Trail Agreements: We have 4, all from new owners from property sales.

<u>Hunting Closures:</u> Rte. 41 area Cortland County: A short and permanent hunting closure has caused a very long road walk. The only thing we can do at this time is to improve the road walk. We are talking to two other owners so far. We have ideas but they must wait to see what develops.

<u>Easements:</u> The Exec. Comm. should consider a policy that all easements shall have no hunting closure unless it is insisted on at the time of the donation. The FLTC Board is working on an easement enforcement policy.

<u>Another Re-location:</u> This one is on top of Jones Hill on private property. The owner is frustrated by trespassers that caused high use trail impact at Tinker Falls and Labrador Hollow. MT bikes are the usual problem. Scouting by Tony Rodriquez, Mary Coffin and Ed O' Shea finds the Jones Hill re-location won't be so simple and nothing stops the determined trespasser who is common in high use areas.

<u>Landowner Identification Maintenance:</u> We need the complete name(s), address, parcel number, e-mail and phone number updated at least once per year. Also, a trail overlay on a tax boundary map. I proposed a computer program be written at the FLTC last April and it was met with much interest as a basic trail management tool. It was delegated to a specialist but no news yet.

The only practical way is for Mt Morris headquarters would do the updates and inform the sponsors to follow-up and confirm. Only a few people in FLTC do tax maps and tax rolls. There are 65 individuals and 15 groups who sponsor the FLT trail sections. Hiker Right-of-Way Sign: I proposed to the FLTC last June that the attached sign to be posted on several trail locations. This involves the Dennis violation of our trail easement. FLTC is seeing its lawyer and no decision is back yet.

New Lean-to in Hoxie Gorge: This is a fine new lean-to on a very pretty site in a DEC forest. But a private land closure nearby could put it out of business. Lean-tos must have two-way accesses secured by easements or public lands. This area is most distant for ADKON and is now maintained by local volunteers. A new trail organization is needed here to serve the FLTC.

9. North Country Trail Team (NCTT)-Team Leader: Mary Coffin

- 1. <u>Volunteer Trail Work Hours</u>: 66 chapter members have participated in 1,935 person hours on the North Country National Scenic Trail [NCNST] concurrent with the FLT and explorations on the Adirondack route. Approx. 80% (83 miles) of ADK-ON's FLT sponsorship is also NCNST. Thanks to all trail volunteers.
- **2.** FLT Map 20 relocations and Revisions: Two landowners and DEC have permitted former trail to be reopened between Underwood Hill Rd. and Baker School House State Forest Rd. to replace most of the road walk on M20 except during hunting season. Unfortunately, we lost permission for the trail between Rt. 41 and Mt Tego. We still need to construct a 28' footbridge across Smith Brook (protected stream) after the DEC permitting and SEQR processes are complete.
- **3.** <u>Community Family Trips:</u> Nine people participated in 2 trips in the Fabius and New Woodstock area on NCT/FLT Map O2
- **4.** Adirondack NCNST route: We offered 3 recreational hikes on Adirondack NCT route trails (Stone Dam Lake & Big Brook, Long & Rock Ponds, Pillsbury Lake), cleared trail (cross cut saw team) in Siamese Ponds Wilderness, scouted off trail in Black River Wild Forest and sent the GPS tracks to DEC as potential new trail.
- **5.** North Country National Scenic Trail Day, Sat. Sept 24: ADK-ON hosted two hikes, one on the Adirondack route in West Canada Lakes Wilderness and one on NCT/FLT Map O2 in Madison County.

12. Pigeon Lake Wilderness Area

Chair: Sigi Schwinge Steward and Work Hike Coordinator

We had 6 maintenance hike outings in the PLWA this year:

In May 6 volunteers walked in from Big Moose/Higby Rd. and worked a loop of the West Mtn. trail to Chub Pond, Queer Lake trail and Mays Pond trail back to the trailhead.

In May, Rich Adams checked the West Mountain Trail to the summit and did some blow-down removal.

In June 8 volunteers worked the Windfall Pond and Chain Ponds trail with heavy blowdown.

In July, Kathy Disque had a work hike on the center part of the Norridgewock Trail, plus another work trip to side cut the section from Oswego Pond to Twitchell Pond trailhead and remove blow down. In September Kathy led a recreation hike from Twitchell Pond trailhead to Beaver River. The trail needs professional work and a DEC Forester went out in August to take a look at the southern section. Hopefully, planning has begun at DEC to restore the trail

In August 6 people finished the work from the Windfall Pond trailhead, Queer Lake and Chain Ponds trail.

In October 8 people came out to admire the luminous fall colors around Cascade Lake and we worked the Cascade Lake connector trail to the Chain Ponds Trail.

The DEC opened the lower portion of the trail to Sucker Brook Bay to bicycles, but it is still a foot trail from there to the summit. The chapter will no longer sponsor West Mtn. Trail, but Rich Adams, who has a cabin nearby and likes to hike the trail, is interested in taking over.

I want to thank everyone who hiked and worked alongside me for doing this important service for all persons who had a better hiking experience because of it. Please support us again next year.

15. Trails Committee-Chair: Tony Rodriguez

Trail Sections Transitions:

- Cortland County route 41/McGraw-Marathon Road: Pursuant to Bill & Mary Coffin's negotiations the new landowner of a previously closed section-north and south of McGraw-Marathon Rd.-has granted permission to reopen the former trail, which will eliminate a currently lengthy road walk, and reconnect with Baker Schoolhouse State Forest. On the negative side, at the landowner's insistence, the short connection from route 41 to Mt. Tego is closed, requiring a road walk leading to the Taylor Valley State Forest off Telephone Road.
- Morgan Hill State Forest: The lumber company has asked for closure of their part
 of the trail ascending from Spruce Pond to Jones Hill. Apparently, they are not
 happy about bikes that have been trespassing through their property. We are
 working to obtain approvals from Onondaga County and DEC to establish a
 reroute.

- Various trail sections were logged this season but impacts on the trail have not been significant, so hikers have not been restricted.
- Three of our trail stewards can no longer maintain their trail sections, so if you are interested in joining our steward family please let me know. The sections are: Morgan Hill Road to the Hemlock Glen leanto; Skyline spur trail in Heiberg Forest; Chippewa Falls spur trail. On the other side of that coin we want to welcome back Rich Adams as a steward, and John Heslop as a new steward.
- The FLTC has initiated a process for obtaining trail usage stats on an annual basis. If you steward a section with a register box it should be equipped with a new, yellow, waterproof register notebook for that purpose. We have managed to supply most of the boxes, but still have a few more to go, so if your section is lacking one please contact me.
- Trail work statistics for the season ending 9/30/2016: there were 189 work events totaling 2814 hours of work; there were a total of 15 individuals who contributed more than 50 hours each, topped by Bill Brosseau and Mary Coffin with over 200 hours each. Thanx much to all who participated.
