I am excited to share a personal note that I have completed my quest to climb the 46 ADK high peaks ending on Armstrong





National Trails Day was celebrated by our Chapter on June 3 by a hardworking group of volunteers, near Chippewa Falls, on a new trail section. Under the leadership of Harold Kyle, weed whacking, benching, pruning, and construction of new stairs were the activities of the day. Other trail clearings and projects were held in the Tioughnioga Wildlife Management Area, the Black River Wild Forest and on the Onondaga trail to Jones Hill (near the Morgan Hill State Forest). Thanks to our leaders Dick Frio, Harold Kyle, Mary Coffin, and Bob Rosati for organizing these outings and thanks to all of our volunteers for your hard work!

Outings Policy Changes! The ADK board has approved a new outings policy in April entitled "Outings and Trip Leader's Guide". The goal of the new policy is largely to gain more favorable Directors and Officers insurance for the ADK. The policy will align chapters to establish common protocols for outings that will include a Leader Certification program with

oversight by the Club. The Chapter's practices for selecting and mentoring volunteer chapter trip leaders will be enhanced by this change. Chapter Leaders will be required to certify Level One, Two or Three to continue leading outings with the ADK. A combination of online courses, in-class and hands-on training will be offered at no cost or reimbursed in full by the ADK. The timeline for completion is by the end of 2024. This is a great opportunity for members of our Chapter to grow their outdoor leadership skills and give back to our Chapter as a hike leader. ADK Volunteers Clear Trails on the NCT Route in Black River Wild Forest

Building new trails such as the North Country Trail across the Adirondacks is exciting work. But once a trail is constructed it must be maintained or it will grow over. Trails in the Forest Preserve are adopted by ADK members, Chapters, families and other groups or individuals who become Trail Stewards like we have on local trails. Volunteer Trail Stewards venture into the Adirondack woods with loppers and saws to keep trails open.

ADK Onondaga has adopted the Little Woodhull Lake Trail and the beginning of the Stone Dam Trail. Both are close to home, part of the North Country National Scenic Trail and located just off North Lake Road in Black River Wild Forest. On July 15, twelve chapter members worked to clear the Little Woodhull Lake Trail. We divided into three teams. The strongest hiker team took the twoperson crosscut saw, axe and wedges and hiked the furthest into the woods to remove blowdowns and post some trail markers. They found blowdowns to remove and that the trail deepest into the woods was so little used that the tread was disappearing. The middle group removed deadfall and lopped off branches growing

into the trail in the middle section. And the more leisurely workers mostly lopped growth and removed smaller blowdowns along the tread on the first two miles. By this divide and conquer method the group

collectively removed 8 blowdowns, cleared 4 miles of trail and donated 6 hours of sweat equity while driving only 3 hours round trip.

Continuing responsibilities, on July 22, our volunteer crew of 6 returned and cleared the neglected Stone Dam Lake Trail. Over the course of 3 miles the crew removed 22 blowdowns, lopped off many encroaching shrubs and overhanging, "in your face branches," and posted DEC markers while logging 5.5 hours of work and three hours' drive time.

Thank you to the following volunteers: Jon Bowen, Kathy Bowen, Jamie Condon, Joe Condon, Kathy Chillemi, Lisa Druke, Dan Dorrough, Ruth Dorrough, Dick Frio, Dick Harper, Kim Putnam and Bob Rosati. The next goal in this area is to flag a potential NCT Corridor between these two trails, Stone Dam Lake and Little Woodhull Lake Trails. Thanks folks.

🜲 Talk of the Trail - Fall 2023

The season is winding down for us this year but stay tuned for opportunities to join one of our outings next year. Thanks to everyone who helped out with outings and who volunteer as stewards for sections of our 74 miles of trail. Reach out to me at <u>harold@cnyhikes.com</u> if you'd like to hear about volunteer opportunities.

The ADK Onondaga trails crew has put in many hours this summer keeping the trail clear and building puncheons. In addition to regular crosscut saw and string trimmer outings, we had three productive events on the FLT trails we maintain.

Last year we built a new trail to connect Cuyler Hills State Forest to Mariposa State Forest, but there are still several steep segments by Chippewa Falls. On National Trails Day this year, a crew assembled about 20 box steps to help the footing and to prevent erosion. These steps are dug by hand deep into the sidehill and are filled with the loose rock we uncover. It's a nice stretch of trail if you're looking for a steep climb. Parking is available on Route 12 where the trail continues east.

The north end of the Onondaga Trail at Tioughnioga Wildlife Management Area needed quite a bit of TLC this year, so thankfully an enthusiastic crew showed up on July 9. First, we cut back brush and multiflora rose. Then, 25 long puncheons were hauled in and installed in swampy parts. New York State requires the trail to stay on the periphery of the WMA, so we can't route around the wet areas as we would like. The new puncheons should allow people a more pleasant hiking experience.

We had two days of puncheon building on Jones Hill in Morgan Hill State Forest planned for July, but inclement weather forced us to do everything in one day. This stretch is one of the most heavily used sections of the FLT we maintain, so the wet areas have become rutted and braided over time. By the time the day was over, we'd installed about 34 new puncheons to make the trail more sustainable.

Our local ADK hikes generally take place on trails that are repeated over and over. The information below may provide you with another place to walk.

Despite being aware of the Split Rock area's existence, I had never paid too much attention to it. I am always looking for new places to hike and explore and earlier this year, I was playing with the Gaia app on my phone, and I thought I'd see what was in the Split Rock area. As soon as I zeroed in, I noticed an area of trails, one of which is the old Auburn-Syracuse trolley line. After exploring the area, I decided to add this area to our ADK schedule.

Eight people showed up to do this outing on June 24, a day when rain was predicted. The trailhead is on Kasson Road, left side, about 1 mile from Route 5 and the Camillus Tops store. This area is Edgecliff Park, owned by the Onondaga County Parks Department.

The old trolley line starts at this small parking area and continues for a flat walk for two miles to Onondaga Boulevard. This would make an easy out and back 4 mile walk.

Our group hiked in for about a quarter mile and turned left heading

down towards the bottom of the cliff. The trail winds around with some short loop side trails before returning to the old trolley line. We continued down the trolley line passing various old structures that were associated with the trolley line. Eventually we reached a private residence and Onondaga Boulevard.

At this point, we turned right, up a paved road that went to the old quarry. On the left side of the road, we could feel cold air emanating from one of the old tunnels in the area. Continuing up the hill we reached a flat area where there were buildings at one time. Straight ahead on the left is the stone crusher which looks like a Mayan temple. The group stopped to look around and explore and also to identify wildflowers like Viper's bugloss and gold moss stonecrop, among others. Theresa Evans was in attendance to give names to the flowers we discovered.

We headed left at the base of the stone crusher, retracing our steps and heading up a rocky trail to the top of the stone crusher at the top of the quarry. Unfortunately, some people had a party there recently and Peg Whaley found a grocery bag which she filled with discarded aluminum beer cans. The trail at the top of the crusher provides views of the quarry below.

Jon Bowen We continued along the top of the quarry where there are many side trails. This area is used for off-road biking, and they have built a network of trails. We continued for quite a while on one of the trails, but any trail to the right would connect to the main road in the old quarry. We eventually reached a road which is wider and in better condition than the bike trails.

The group continued down this old road passing some boulders that said "No ATVs" as well as a red sign indicating that a local cycling club maintained the trails. Eventually we turned off the old road on a short trail that took us back to the trolley line trail and then to our cars.

Everyone in the group thought this to be an interesting area and several said they would research the area and the stone crusher. We completed 2 loops and 4.5 miles, and the rain held off until after we had finished our exploration.

Follows are recent communications from the Advisory Council and ADK on the new Outings Leader Guide approved by the Board on April 19, 2023:

July 4, 2023

By Tom Ortmeyer, Acting Advisory Council Chair Why the OLG is needed and Where Do We Stand?

A bit over a year ago, we learned that ADK's practices for selecting and mentoring volunteer chapter trip leaders was outdated and did not meet requirements for favorable insurance coverage. In particular, the requirements in the Volunteer Protection Act of 1997 (VPA) for non-profit organizations were not being met. While the volunteers were and are protected by the act, the organization was not. In particular, this law requires any non-profits board and officers who hold fiduciary responsibility to develop and implement a certification program for its volunteers.

The Advisory Council was chaired with developing a draft OLG, and then the Council Chair Ned Garner assigned this task to the AC's outings and Meetings Committee. The Committee was asked to act quickly, due to the liability exposure of ADK. The draft was developed, circulated, revised and approved by the AC. It then went to the ADK staff for revision and editing, and the edited version was presented to the board this past January, where it was approved.

ADK Communications, updated July 21, 2023 By Julia Goren, Deputy Executive Director

Earlier this spring, the ADK board of directors voted unanimously to adopt an Outing and Leader's Guide that establishes organization-wide protocols that will create safer and more enjoyable experiences for our participants. This is the result of a robust year-long process led by the Advisory Council's Outings and Meetings Committee.

To lead outings in the future, leaders will have to take specific courses and certification programs. The requirements vary depending on the level of the outing. A grace period starts on June 1, 2023 which gives leaders the following time periods to acquire these certifications:

Level One: By December 31, 2023 Level Two: By December 31, 2024 Level Three: By December 31, 2024

Requirements to qualify for each Level:

Level 1. To be certified as a Level 1 Leader, the person must:

- Be eighteen (18) years of age or older;
- Be a current member of ADK;

• Take Sexual Harassment Prevention Training annually (proof that someone has taken this training pursuant to their employment, or as part of some other requirement is acceptable);

Complete Leave No Trace Training, either in-person or online

 Co-lead at least one outing with a certified outings leader or have the equivalent experience from leading a previous outing at a similar level; and

• Have knowledge of the ADK Outing and Trip Leaders' Guide that is approved by the ADK Board.

Level 2. To be certified as a Level 2 Leader, the person must:

Complete Level 1 Certification;

 Co-lead at least 2 outings with a certified outings leader at this level or have the equivalent leadership experience from having led previous outings;

- Complete Red Cross First Aid or equivalent;
- Complete Map & Compass Fundamentals or equivalent (not necessary for paddling leaders).
- Complete ADK's Outdoor Leadership 101 or equivalent

Level 3. To be certified as a Level 3 Leader, the person must:

Complete Level 2 Certification;

• Complete Wilderness First Aid Certification from either Red Cross or Wilderness Medical Associates (may also take this in lieu of Basic First Aid);

Complete a Leave No Trace Trainer Course





Additional Information, updated July 21, 2023:

Suggested training schedule:

This spring, Education staff piloted a volunteer symposium weekend training with all needed trainings for various volunteer positions. It was highly successful.

We propose offering a weekend this fall with all of the outings guide in-house trainings offered (meaning: Map and Compass, Basic First Aid, Outdoor Leadership 101, Leave No Trace training) on November 17-19th, 2023. If successful, this would be offered again in the spring.

ADK staff can offer 4 additional Map and Compass Fundamentals and Outdoor Leadership 101 courses specifically for outdoor leaders. These can be offered online or in person (perhaps 2 online and 2 inperson) over the course of the year. These courses would be run at no cost to participants. If the participants are unable to sign up for these particular courses, they can sign up for the open enrollment Map and Compass and Outdoor Leadership courses that are offered frequently throughout the year (but would need to have their chapter reimburse them for the course cost.) American Red Cross First Aid and CPR-there is an online training (asynchronous) that costs \$37. Chapters can budget for reimbursement to all outings leaders.

We also have an instructor at Heart Lake who can offer these courses. We would charge nothing except the \$25 cost for the certification. (American Heart Association) (We would offer 3 of these in 2024, 2 likely tied to Outings Guide training weekends.)

Wilderness First Aid:

July 31, 2023 **Onondaga Chapter Bylaw Proposed Amendments:**

Amendment 1

Article V.6

Reason for the change: the ADK By-laws (March 1, 2022) Advisory Council Trustee term was revised from two year to three-year term and not more than three consecutive, three year terms.

ARTICLE V – OFFICERS

6. The ADK Advisory Council Trustee is a Voting Member of the Chapter, not in the employ, full or part time of ADK, and shall be elected by the Chapter as the ADK Trustee to serve on the ADK Advisory Council for a threeyear term, starting January 1, and renewable two times. The ADK Trustee shall not be elected for more than three consecutive, three year terms.

Amendment 2

Article VI.4

Reason for the change: The Chapter(s) must submit the Treasurer's report including the equipment inventory annually.

ARTICLE VI - COMMITTEES AND EQUIPMENT

4. The equipment inventory as a Chapter asset will be submitted to both the audit and Treasurer's report annually after EC approval.

Amendment 3

Article VI.2.12

Reason for the change: Clarify the Internet Communications Committee role.

ARTICLE VI - COMMITTEES AND EQUIPMENT

2.12 The Internet Communications Committee shall develop and maintain the chapter website, and any other internet communications (such as distribution of the electronic newsletter, Facebook, Instagram, Google Group, and other social media approved by the Executive Committee).

BY-LAWS

Onondaga Chapter, Adirondack Mountain Club Inc.

ARTICLE I - Name. This organization shall be called the Onondaga Chapter, Adirondack Mountain Club Inc., hereinafter referred to as the Chapter. All references to committees (with the exception of the ADK Advisory Council) refer to those of this Chapter.

ARTICLE II - Organization. This organization shall be regulated by the Articles of Incorporation and Bylaws of the Adirondack Mountain Club Inc., hereinafter referred to as the ADK.

ARTICLE III - Objectives. The general objectives of the Chapter shall be to foster conservation, environmental advocacy, and educational and recreational programs that are environmentally and ecologically sound and shall support the mission and goals of the ADK. Specific objectives shall be:

1. To advocate and broaden popular support of that part of Article XIV, Section 1, of the New York State Constitution which provides that the lands of the state constituting the Forest Preserve shall be forever kept as wild forest lands.

- 2. To conserve natural resources, especially of the Adirondacks.
- 3. To protect wildlife.
- 4. To advance programs for forest management within and outside of the Forest Preserve.
- 5. To sponsor and encourage responsible outdoor recreation in the Adirondack Mountains in a manner consistent with the wild forest and wilderness character of the region.
- 6. To organize and conduct outings.
- 7. To collect and publish information about the Adirondacks.
- 8. To assist the State Department of Environmental Conservation in the construction, marking and maintenance of sustainable trails.
- 9. To construct and maintain trails for public use.
- 10. To support use of the Finger Lakes Trail and the North Country National Scenic Trail.
 - The Chapter defines a foot or hiking trail as pedestrian use only with no trail riding of any kind. A trail distance that meets this qualification is a dedicated foot trail and is authorized by a Chapter agreement with the landowner authority.
 - A trail connector is where motorized and or non-motorized riding are otherwise authorized by a land authority. The Chapter uses trail connectors as temporary and all will be replaced with dedicated foot trails over an indefinite period of time. The dedicated foot trail and trail connector are the only two Chapter designations.
 - The Finger Lakes and North Country trails will be known by the purpose and objective of their dedicated foot trails and not by use of temporary trail connectors.
 - The need by many people to have primitive foot trail experiences on single use paths is as important as any other kind of trail recreation.

ARTICLE IV- Membership

- 1. Membership in the Chapter shall be open to any person who meets ADK qualifications.
- 2. Classes of membership are established by the ADK. All Chapter members over age 18, except Affiliates, shall have Chapter voting privileges.
- 3. Dues shall be fixed by the ADK. Dues for Affiliate members shall be fixed by the Chapter Executive Committee.
- 4. Non-payment of dues shall subject the member to termination in accordance with the ADK by-laws.
- 5. ADK members in good standing shall be automatically accepted as members of the Onondaga Chapter upon written application.

ARTICLE V - OFFICERS

- 1. The officers of this Chapter shall be: the Chapter Chair, the Vice-Chair, the Secretary, and the Treasurer. All officers shall be voting members of the Chapter.
- 2. There shall be two (2) Chapter Advisors. These two Chapter Advisors shall be voting members, who have previous experience on the Executive Committee of the Chapter if such candidates can be reasonably enlisted. Otherwise, any other Chapter voting member may be elected Chapter Advisor. The immediate past Chapter Chair shall be offered the post of Chapter Advisor, if willing to serve.
- 3. The Officers and Chapter Advisors (other than the past Chapter Chair) shall be elected at the Fall Annual Meeting for a term of one year and shall take office on the First of January.
- 4. The Officers shall perform the duties customarily associated with such offices and in accordance with job descriptions maintained by the Executive Committee.
- 5. Vacancies amongst the Officers, Chapter Advisors or ADK Advisory Council Trustee shall be filled by the Executive Committee within one month from their occurrence. The Vice-Chair shall fill the office of the Chapter Chair for the unexpired term, if that office becomes vacant. Other replacement candidates shall be selected from the voting membership.
- 6. The ADK Advisory Council Trustee is a Voting Member of the Chapter, not in the employ, full or part time of ADK, and shall be elected by the Chapter as the ADK Trustee to serve on the ADK Advisory Council for a three-year term, starting January 1, and renewable two times. The ADK Trustee shall not be elected for more than three consecutive, three year terms. The Trustee will represent the Chapter at Advisory Council meetings and report back to the Chapter ADK Board decisions that may affect chapter operations and/or directions. An Alternate Trustee will be appointed by the Executive Committee to represent the chapter at Advisory Council meetings when the trustee is unavailable.

ARTICLE VI - COMMITTEES AND EQUIPMENT

- 1. Executive Committee
 - 1.1. The Executive Committee shall consist of the elected Officers, Chapter Advisors, ADK Advisory Council Trustee and a leader of each standing committee.



- 1.2. Between the meetings of the membership, the conduct of Chapter business shall be the duty of the Executive Committee. The Executive Committee shall meet at least six (6) times a year, as convened by the Chapter Chair.
- 1.3. Motions and other business shall be approved by a majority vote of those voting. Abstentions will be recorded but will not be counted as negative or positive votes.
- 2. Standing Committees:

untain Club

- 2.1. There shall be ten (10) Standing Committees. These committees shall be titled: Conservation, Membership, Newsletter, Outings, Publicity, Internet Communications, Education, Social, Trails and Landowner Liaison.
- 2.2. After consultation with the Executive Committee, the Chapter Chair shall appoint the leaders of the Standing Committees. All committees and the committee leaders are responsible to the Executive Committee. Any Chapter Officer, Chapter Advisor or ADK Trustee, except the Chapter Chair, may also serve as a committee leader.
- 2.3. Committee leaders shall appoint any members needed for their own committees and shall serve starting the First of January.
- 2.4. The Conservation Committee shall carry out the conservation responsibilities of the Adirondack Mountain Club.
- 2.5. The Membership Committee shall process applications for membership and supervise membership and quest procedures.
- 2.6. The Newsletter Committee shall prepare and publish information on general Chapter activities, etc. as requested by the Executive Committee.
- 2.7. The Outing Committee shall prepare for and publish the Chapter Outing Schedule including the Social and Trails Committee activities.
- 2.8. The Publicity Committee shall handle all Chapter publicity desired for the best interests of the Club, at the direction of the Executive Committee.
- 2.9. The Education Committee shall provide information to the membership on issues of interest to ADK. It shall accept other educational tasks assigned by the Executive Committee.
- The Social Committee shall arrange and conduct Chapter functions, mainly social in nature. 2.10.
- 2.11. The Trails Committee shall arrange for and have charge of all Chapter activities related to trail planning, construction, and maintenance. The Trails Committee will coordinate their activities with the Outing Committee and Landowner Liaison Committee.
- 2.12. The Internet Communications Committee shall develop and maintain the chapter website, and any other internet communications (such as distribution of the electronic newsletter, Facebook, Instagram, Google Group, and other social media approved by the Executive Committee). The information shall reflect the interest of the ADK and be in the club's best interest.
- 2.13. The Landowner Liaison Committee has the responsibility to protect and preserve any hiking trails sponsored by the Chapter including the Little Woodhull Lake Trail, Finger Lakes Trail, North Country National Scenic Trail, and any other hiking trails formally adopted by the Chapter by written agreement including misc. trails on an as needed basis in the Chapter adopted Pigeon Lake Wilderness.
- 3. Equipment: All equipment purchased with Chapter funds shall be the property of the Chapter and the custodians of the same shall submit an annual inventory not later than October 15 to the Chapter Chair, Treasurer and Secretary. Custodians shall be appointed by the Executive Committee.
- 4. An Auditing Committee of two members shall be appointed by the Chapter Chair by December 1. An audit of the accounts of the Treasurer shall be accomplished the following January and a written report documenting the audit provided to the Executive Committee at their February meeting. This report shall be read at the Spring Business Meeting. Upon receipt of equipment inventories, the Secretary shall forward them to the Auditing Committee for verification. The equipment inventory as a Chapter asset will be submitted to both the audit and Treasurer's report annually after EC approval.
- 5. Nominating Committee
 - 5.1. A Nominating Committee shall be appointed by the Executive Committee not later than first of June. The Committee shall consist of not less than three members, none of whom may be a member of the Executive Committee. This committee shall present a slate of nominees for the offices of Chapter Chair, Vice Chair, Secretary, Treasurer, and two Chapter Advisors. Notification of the slate of nominees shall be given to voting members at least six weeks prior to the Annual Meeting. A nomination for ADK Trustee shall be included in the year prior to the completion of a sitting ADK Trustee's term.
 - 5.2. Nothing in this section shall be construed to bar nominations for any elective office from the floor. The consent of all nominees must be obtained previously.



ARTICLE VII - MEETINGS

- 1. The Annual Meeting shall be held within the period between October 24 and November 30. The date, time, and place shall be determined by the Social Committee with the approval of the Executive Committee. Notice of such meeting shall be included in the electronic newsletter mailed to Chapter members not less than six weeks in advance of the meeting.
- 2. The Regular Spring Business Meeting shall be held within the period between March 15 and May 15. The date, time, and place shall be determined by the Social Committee with the approval of the Executive Committee. Notice shall be distributed to Chapter members not less than six weeks in advance of the meeting.
- 3. Special Chapter meetings may be called by the Chapter Chair. Upon request of 15% of the membership, a special meeting shall be called by the Chapter Chair within 3 weeks of such a request. Notice of such a meeting shall be mailed or included in the electronic newsletter to members not less than two weeks in advance of the proposed meeting.
- 4. Chapter business may be conducted at Chapter regular and special meetings providing that advance notice of the business to be conducted is provided to the membership at least six weeks before the meeting.

5. A quorum for Executive Committee meetings shall consist of fifty percent of its members.

ARTICLE VIII - Amendments

- 1. Amendments to these By-Laws may be made by a majority vote of members at the Annual Meeting.
- 2. Proposed amendments to these By-laws shall be provided to the Executive Committee at least eight weeks prior to the meeting when they will be voted upon.
- 3. Notification of proposed amendments to the Chapter By-laws shall be given to voting members at least six weeks prior to the date the voting will take place.
- 4. Extensive amendments approved by Executive Committee: June 20, 2001. Membership approved at Annual Meeting: November 3, 2001.
- 5. Amendment adding the Internet Communications Committee (ninth standing committee). Approved by Executive Committee: March 17, 2004. Membership approved at Annual Meeting: November 20, 2004.
- 6. Amendment redefining the method of approving motions or other business conducted by the Executive Committee. Membership approved at Annual Meeting: November 15, 2009.
- 7. Proposed amendments to Executive Committee. Approved by Executive Committee: 2009
 - a. Amendment adding the Landowner Liaison Committee (tenth standing committee). Membership approved at Annual Meeting: November 15, 2009.

Notice to Participants

Choose only outings suitable to your abilities; call the leader if you are unsure. Outing leaders are not guides; they are volunteers willing to share their knowledge and experience with you. Please give them your cooperation and respect. Stay with the group at all times. Stay behind the leader unless permission is given to go ahead, and then stay within sight of the group. Make sure the leader is aware if you must leave the group. Dress properly for the type outing and the weather, and be prepared for changing weather conditions. The leader has the right to refuse anyone who is not prepared for the outing.

New hikers should call the leader before their first outing. Most outings starting in the morning are designed for a full day with return to the meeting place prior to dinnertime.

Hazardous weather or insufficient snow on snowshoe and/or cross-country ski trips may require a change of destination.

Transportation: Carpooling is the norm. Passengers are expected to contribute toward the cost of the transportation. Refer to the Covid-19 guidance table for carpooling guidance during high community levels.

Risk: There are risks involved in our outings. Anyone participating does so at their own risk, and is required to sign the *Release of Liability Form* provided by the leader.

Overnight Outings: Overnight outings are open only to ADK members.

Dogs: Please contact the leader in advance if you would like to bring a dog. It is up to the leader to decide if a dog is allowed to join the hike.
